# BUSINESS AT STANBOROUGH

The Business department at Stanborough includes Business GCSE, Business A-Level & Economics A-Level. Students can also study a Diploma in Financial Studies.

#### **GCSE Business:**

Business at GCSE level explores the skills needed to be enterprising . The subject considers the practicalities of making a business idea happen and focuses on the implication this has on the different functional areas within a business.

#### A- Level Business:

Students acquire a range of relevant business and generic skills, including decision making, problem solving, and analytical skills. Students are encouraged to use an enquiring, critical and thoughtful approach to the study of business, to understand that business behaviour can be studied from a range of perspectives and to challenge assumptions.

## **Economics:**

The study of Economics allows students to apply economic theory to support analysis of current economic problems and issues. This encourages students to appreciate the interrelationships between microeconomics and macroeconomics.

## **Financial Studies:**

The Diploma in Financial Studies develops the knowledge and skills required for young people to make informed financial decisions by introducing them to the risks and challenges involved in personal finance and the tools for effective planning. Within this, it provides a solid basis for creating financial inclusion, by exploring social-economic trends and their relationship with an individual's circumstances and attitudes.

Overall, Business, Economics & Financial Studies is a discipline that combines well with other subjects. Geography, History, Politics, Law, Sociology, Psychology and Maths all have a link with these subject.

# CURRICULUM KS5

## Level 3—Diploma in Financial Studies

## The course content includes the following 4 units:

- 1. Financial Capability for the Medium and Short Term
- 2. Financial Capability for the Medium and Long Term
- 3. Sustainability on an individual's finances
- 4. Sustainability of the financial services system

Students not only learn how to manage money effectively, they also learn about income and expenditure, credit and debt, insurance, savings and pensions, financial products, and how public money is raised and spent; helping them prepare for financial independence.

### Assessment

Each unit is assessed through a combination of:

- Multiple Choice Questions (Part A)
- Written paper based on a pre-release (Part B).

The overall qualification will be graded A\* - E which can attract the maximum UCAS points available contributing towards university entry.

## Pathway

Jobs in personal finance include, Banking, Investments, Financial advisory, Insurance, HR Business related jobs and so much more.

Jobs in Business & Economics include, Careers in the City, Civil Service, Banking or in the Financial Sector. Also, careers in journalism, education and the charity sector will all be helped by a study of Business & Economics.



# **CURRICULUM KS4**

#### **GCSE Business**

## **Course Content includes the following and more:**

- Enterprise and entrepreneurship
- Spotting a business opportunity
- Putting a business idea into practice
- Making the business effective
- Understanding external influences on business
- Growing the business
- Making marketing decisions
- Making operational decisions
- Revision and Exam preparation

#### Assessment

The Pearson Edexcel Level 2 GCSE (9–1) in Business consists of two externally-examined papers. Both exams will be taken in Year 11.

Written Exam 1	50%	1 hr 45 mins
Written Exam 2	50%	1 hr 45 mins

Key assessments will take place at the end of each unit. However, examination questions will form part of the learning process and will be given for homework. Mock examinations will also take place.

#### **Pathways**

The next stage for students after GCSE may be to progress to Business Studies 'A' level, Economics 'A' level, or LIBF Finance . Beyond this students may aspire to degrees, careers or Apprenticeships as Solicitors, Public Relations Account executive, Bankers, Stockbrokers, Marketing Executives, Accountants, and so much more.
