Dear Parents/Carers

Year 7 Residential Visit to PGL Caythorpe Court, Lincolnshire.

I am pleased to be able to offer your child the opportunity to take part in the Year 7 school trip to PGL Caythorpe Court, in Lincolnshire from Wednesday 18th June to Friday 20th June 2025.

The trip will be led by Mrs Aubrey and will be hosted by PGL. During the 3 day and 2 night visit we will have a tailored visit packed with different activities.

The aim of the visit is for students to learn through adventure in a safe yet challenging environment led by a team of qualified and experienced instructors. Students will take part in a series of adventure activities designed to develop leadership skills using resilience, resourcefulness, decision making and practical thinking. The Caythorpe Court Centre boasts 65 acres of rolling countryside with land activities throughout the fields and woods with a selection of water sports on the lakes. They have this year invested in a new-style super high ropes course, in the woodland! As well as the brand new woodland high ropes course there are giant stand-up paddleboards and axe throwing added to its list of newest activities. The total cost of the trip is £350 per student which includes all meals from Wednesday evening until Friday Lunchtime, accommodation and return coach travel from school.

Please note that the full balance must be paid by **3rd March 2025**. You are welcome to pay the instalments in larger amounts if you wish however, each deadline must be met. Once deposits have been paid to PGL they are non-refundable and terms and conditions will apply and any late cancellations may incur loss of further money. In addition, any student who is subject to serious disciplinary action between now and the start of the trip is at risk of forfeiting their place without refund. We hope that we do not have to take such action.
